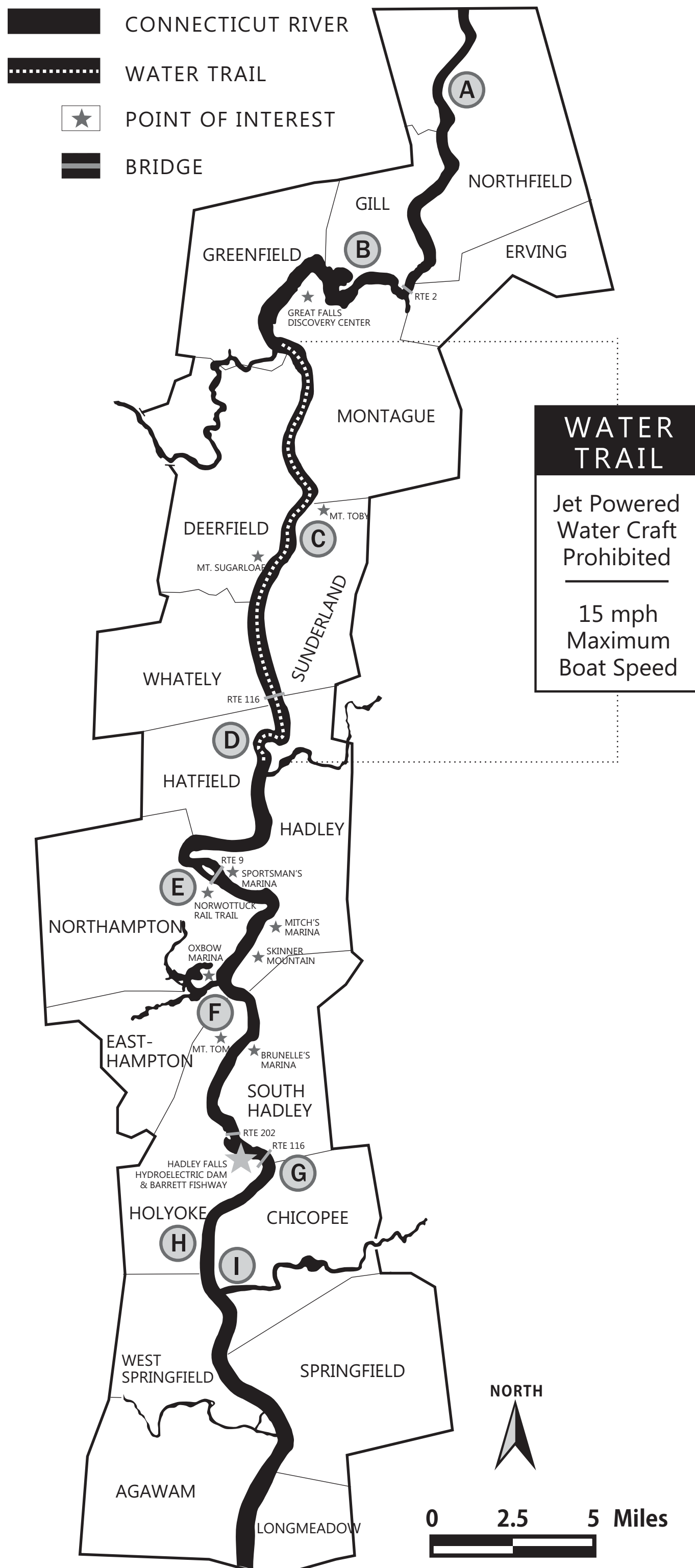


# CONNECTICUT RIVER GREENWAY STATE PARK

## CONNECTICUT RIVER ACCESS POINTS

- A. **Pauchaug Access**  
Northfield. One mile north of Northfield Center on Route 63. Paved parking area and ramp. The boat ramp can accommodate canoes, fishing boats, and recreational motorboats.
- B. **Barton Cove Access**  
Gill. 1.5 miles east of Turner's Falls on Route 2. Paved parking and ramp. The boat ramp can accommodate recreational motorboats, canoes, and fishing boats.
- C. **Sunderland Access**  
Sunderland canoe and fishing access managed by the town of Sunderland. Access point is located at the end of School Street on the north side of the Sunderland Bridge. Limited parking.
- D. **Hatfield Access**  
Hatfield. One mile north of Hatfield Center. Shallow draft, lightweight boats and canoes.
- E. **Elwell Recreation Area**  
Northampton. Damon Road at Route 9 and I-91. Canoe and rowing access only. Paved access ramp to a wheelchair accessible dock on the river. Limited parking.
- F. **Oxbow Ramp Access**  
Easthampton. Take I-91 to exit 18 south on Route 5 in Easthampton. Paved ramp customary use by high powered recreational craft and larger fishing boats. 35 parking spaces.
- G. **South Hadley/Chicopee Access**  
James Street at the South Hadley/Chicopee town line downstream from the Holyoke Dam. Gravel ramp suitable for shallow draft fishing boats. Popular during the shad fishing season. 6-8 parking spaces.
- H. **Jones Ferry River Access Center**  
City of Holyoke. Located on Jones Ferry Road off Main Street in South Holyoke, 1 mile from the intersection of Main Street and Route 5. Steep, paved ramp suitable for small craft. Low river conditions most of the season. Limited parking.
- I. **Chicopee Access**  
Chicopee. One half mile off Route 116 on Melina Street. The surfaced ramp can accommodate shallow, moderate and deep draft recreational and fishing boats. Easy canoe and rowing shell access. 32 parking spaces.

**Canoe Portage Service** - The Holyoke Gas and Electric Department (H.G.E.) provides a canoe portage service around the Holyoke Dam. In order to utilize this service, prior arrangements are required and can be made by calling H.G.E. offices at (413) 536-9472 during our normal business hours.
