

HG&E Selected for up to \$5 Million in Federal Hydroelectric Incentives

On September 5, 2024, the Department of Energy's (DOE) Grid Deployment Office announced that several Holyoke Gas & Electric (HG&E) hydroelectric projects are eligible for up to \$5 Million in total incentives under DOE's funding opportunity for Maintaining and Enhancing Hydroelectricity. With nearly 60% of the city's electrical power generated by local hydroelectric resources, this federal investment will help HG&E maintain the reliability and sustainability of its clean



energy infrastructure, while offering customers the some of the lowest utility rates in the region.

"As a local municipal utility, with a large environmental justice population, HG&E works hard to maintain our local carbon-free energy infrastructure, improve system reliability, and keep our customer rates at some of the lowest in the region, and that includes pursing available grant opportunities to offset those costs," said James Lavelle, General Manager of HG&E. "These federal funds will support important projects that will ensure the continued operation of our hydroelectric assets, which have been a clean, reliable, and affordable power source for Holyoke."

HG&E's hydroelectric resources, including the Holyoke Dam and canal system, have been a key part of the city's power supply for decades. In the coming months, HG&E will work with the DOE to secure the funding and complete these necessary projects. This funding will help ensure the continued operation of Holyoke's clean energy infrastructure, benefitting both the environment and the community by keeping electricity affordable, reliable and renewable. VOC's Fuel Assistance Program, LIHEAP, serves income eligible households throughout Hampden County. Located in Holyoke at 300 High Street and an outreach site at the Holyoke Council on Aging.

What is Fuel Assistance?

Fuel Assistance is a federally funded program that helps low income households pay for a portion of their heating bills during the winter months (November thru April).

How do I apply?

VOC has made it easy to apply from the comfort of your home. Call (413) 552-1548 to apply today and documents can be emailed to fuelassistance@valleyopp.com.

When should I apply?

Apply now! The funding is not guaranteed and is distributed on a first come, first serve basis.

Should I pay my heating bills?

It is important to make payments on your heating bill, even after applying for Fuel Assistance, as your benefit amount may not cover your entire heating bill for the heating season.

How much of my bill will be covered?

Fuel Assistance will cover heat ONLY. As a customer of HG&E you need to know your electricity (with the exception of electric heat) will not be covered by this program. Please do NOT stop paying your bill over the winter months. This program does not cover your entire bill, just the heating portion.

How will I know if I am approved?

You will receive a letter from VOC to indicate whether or not you are approved. If you have any questions, please follow-up with VOC to determine the status of your application.
